Department of Tourism established in the year 1979 under the aegis of Kumaon University, Nainital with a PG Diploma Course with a view of strengthening the youth of the region to take up tourism as a career. The year 2010 witnessed launching of state of the art tourism programme MBA Tourism course a two year full time master's degree programme to equip the youth with the changing scenario of tourism in the state as a whole and region in particular.

The MBA Tourism programme is a two year full time degree course divided into four semesters incorporating 24 modules of study with basics of Management and specialization in Tourism. The course comprises of both the theoretical aspect as well as practical exposure of tourism industry. The course basically focuses to inculcate the first hand experience of tourism industry so as to build professional work force for the fastest growing industry in India. The course also equips the student to take up entrepreneurship in tourism industry so that the major operating force in the region would be the local community itself.

Keeping in view the ever expanding hotel business in the state the Department is planning to open up new vistas for the students of the region by opening up a new study programme Bachelor of Hotel Management, three year full time study programme by 2012 divided into six semester incorporating a total of 28 modules of study covering almost all the aspects of hotel industry.

Number of Seats and Admission Procedure

Presently the Department of Tourism DSB Campus, Nainital has 30 seats. The admission to the course shall be based upon MAT score/Entrance exam conducted by the university.

The Group Discussion, Interview and Counselling for the MBA-Tourism Programme will be held at Department of Tourism, The Hermitage, Kumaun University, Nainital as per the schedule declared by the department at least 15 days prior to the interview.

Reservation shall be applicable as per University/State Government rules.

Admission to the reserved seats will be according to the order of merit of the candidates belonging to these categories as per rules. If the required number of candidate in any of the reserved category is/are not available, the vacancies under such circumstances will be filled up automatically out of the general category candidates provided such general category candidates are qualified/eligible otherwise.

Eligibility

Graduate in any discipline from a recognized university with minimum aggregate of 45% marks or post-graduate degree examination/PG diploma (Tourism) with second division shall be eligible to apply for admission to the MBA- Tourism course. A relaxation of 5% marks in aggregate shall be admissible to the candidates belonging to SC/ST and OBC categories. Students appearing at the final year of degree examination 2011 can also apply. Such candidates, if selected will be admitted provisionally, provided they complete all requirements for obtaining the degree, and produce evidence of having the minimum eligibility requirement by December 2011.

Non fulfilment of this condition will automatically result in the cancellation of the provisional admission.

Cost of Application form and Brochure

The application forms can be collected from the department personally on payment of 1000/- (Rupees one thousand only) and 500 for SC/ST candidates. Opening date for collecting admission forms is 20th May, 2011. The application form can also be downloaded from the

University's website- www.kuntl.org and submitted to the department along-with a Demand Draft for Rs. 1000/- (Rupees one thousand fifty only) drawn in favour of MBA Tourism, Kumaon University payable at BOB Branch, DSB Campus, Nainital.

Fee

Fee shall be charged as prescribed by the university from time to time. A candidate selected for admission shall be required to pay the prescribed fees Rs.40,000 per annum (Rupees forty Thousand only) in full and should secure admission on or before the last date notified for the purpose. Failure to do so will result in forfeiture of his/her claim for admission and the vacant seat will be offered to the next candidate in order of merit. A separate fee of Rs. 15000/- for two field trip is to be deposited in full at the time of admission. Any fee, once paid shall not be refundable.

Attendance

No candidates shall be considered to have pursued a regular course of study unless he/she is certified by the Head of The Department to have attended three-fourth of the total number of lectures, tutorials, field trips, on-the-job training and seminars conducted in each semester during his/her course of study.

Miscellaneous

- i) The Department of Tourism can make any change in the scheme, particularly in respect of the courses prescribed, with a view to adopt and cope up rapidly changing management scenario on the one hand and to make the requirements of the jobs, created in different sectors of the economy, on the other.
- ii) All papers are subjected to the decision of the Board of Studies. Out of the different specialized areas, the student shall be allowed to opt for only those areas and courses for which the facilities exist in the department.
- iii) Conduct of the programme shall be guided by the rules and ordinances of the MBA-Tourism programme.
- iv) In accordance with the directions of the Hon'ble Supreme Court ragging in any form is strictly prohibited in the Department.

- v) All disputes are subjected to jurisdiction of Nainital Court only.

Application form complete in all respect should reach the department latest by 15th June, 2011. Department of Tourism, The Hermitage, Kumaon University Nainital.
